Note:

1. For all treatment in the approval Hospitals/Nursing Home/ Centre the liability of the University shall be limited to the rates fixed by the CGHS for such treatment and procedures including room-rent etc. In case hospital charges exceed the CGHS rates individual employees are free to use the services, provided they pay the difference on their own.
2. The aforesaid hospitals have not been enlisted for "Direct Payment Facility". The University after entering into a contract with individual hospitals will notify the same, wherever required.
3. The University employee is required to produce identity card when seeking treatment from these hospitals. There is no need to obtain reference from WUS Health Centre for availing treatment at the approved hospital.
